The following communication, received on 16 April 2009, is being circulated at the request of the Delegation of <u>Indonesia</u>.

Decree of the Minister of Agriculture concerning Requirements of Wood Packaging and Plant Quarantine Action to Imported Wood Packaging Material into Republic of Indonesia

The Draft Decree of the Minister of Agriculture concerning Requirements of Wood Packaging and Plant Quarantine Action to Imported Wood Packaging Material into Republic of Indonesia notified in G/SPS/N/IDN/27 (dated 29 May 2006) has been signed up by indonesia's Minister of Agriculture in February 2009 and will enter into force in September 2009.

The decree stipulates some requirements concerning the importation of wood packaging into the territory of the Republic of Indonesia as follows:

- (a) Through the designated point of entry;
- (b) Notified and presented to quarantine inspector at the designated place of entry for quarantine actions;
- (c) Free from plant quarantine pest;
- (d) Debarked and soil free; and
- (e) Have been treated and marked.
